Club Activities

In 1979 John purchased his first Golden Retriever - Tang . John joined the Golden Retriever Club that year and soon became an active member and competitor in the club and was keen to compete in Field and Retrieving trials. John instigated the GRCV Retrieving Training days at the monthly members comps. In 1980 John Managed the clubs first Retrieving Trial at McLardy's property in Seymour with family. In the same year John managed the clubs first Spaniel & Retriever Field Trial, obtaining a property in Kyneton that was used for many years to come. Over the following 40 years John, along with his wife Vicky, became active members of the Field and Retrieving Trialing community. During this period John and his dog Tang (RT CH Atawhai Tangaroa CM CD) competed and achieved his Retrieving Triali Champion Title. The first Golden to be awarded this title. Keen to give back to the wider Trialing community, John became an Open Field Trail judge in 1987, followed by Championship Judge in 1992. Since this date John has judged many Field trials both in Victoria and interstate including Championship Trials. He was a member of the Victorian RAFT Committee 1996-2001 representing Spaniel & Retrievers, and chaired RAFT lectures, judges training nights and Rule change submissions.

As Retrieving and Field Trials became more popular and seeking more assistance in running these events instigated the GRCV Working Dog Sub - committee in 1988. Still operating today this committee is a vital unit of the Club and responsible for running all types of trials applicable to working gundogs i.e. Retrieving, Field, Obedience, Tracking and now RATG trials including training days. Many prominent individuals in these sports will have at some point in time been inspired and supported through the activities of this sub-committee.

1991 John became Vice President of the GRCV. In 1993 awarded Life Membership of the GRCV.
